PROGRAM STRUCTURE: PREPARES JOB SEEKERS FOR ADMINISTRATIVE CAREERS LEADING TO SELF-SUFFICIENCY THROUGH COMPUTER AND LIFE SKILLS TRAINING, PAID WORK EXPERIENCE, CASE MANAGEMENT, CAREER COUNSELING, PLACEMENT ASSISTANCE, AND LONG-TERM ALUMNI SERVICES.

IMPACT: THE PROGRAM PLACED 35 GRADUATES INTO INITIAL EMPLOYMENT, EARNING AN AVERAGE OF \$16.39/HOUR. IN ADDITION, 40 ALUMNI WERE PLACED INTO NEW POSITIONS OR ADVANCED TO AN AVERAGE OF \$17.93/HOUR. 81% OF GRADUATES RETAINED EMPLOYMENT AT 18 MONTHS FOLLOWING PLACEMENT.

IMPACT: LAST YEAR, 88 PARTICIPANTS WERE PLACED INTO POSITIONS EARNING AN AVERAGE OF \$16.83/HOUR (NOT INCLUDING 7 ALUMNI PLACED INTO NEW POSITIONS AVERAGING \$23.36/HOUR).
